**8.2 Public Works, Property, Main Street Programs, Sewer & Water Utilities-Councillor Williams & Community Heritage and Beautification, Committee Chair:**

Councillor Wade Williams gave the following written reports:

Public Works, Property, Main Street Programs, Sewer & Water:

I have two quotes for asphalt patching around Town. To do necessary repairs would be \$30,000. This would exceed public works budget. Sections requiring long patches are needed to stop further damage usually associated with spring thaw. By catching them early it helps to prolong the life of road and more expensive repairs if they break up. Would like council to consider this extra expense as preventative measures.

General discussion of council with respect to patching and potential future costs related to yearly patching. Council discussed option of getting the patching done now and whatever overlays that can be afforded now to be done; then having the remaining overlays and budget to be looked at again in the fall.

Woods Lane had a sewer blockage. This will require an extra expense to the sewer account. The sewer main had to be increased and steps taken to have updated standards. We are still awaiting the permits for this work.

AA Macdonald Gardens - trying to get landscaping done before August 7, 2010. Awaiting additional cost estimates.

Community Heritage and Beautification:

New signs are installed. Still have to set signs to proper angle. Install ship wheels and cut off posts.

**Following Kings Playhouse Report prepared by Cheryl Perry, Executive Director – July 19, 2010, submitted and read by Councillor P. King:**

The Kings Playhouse is in full swing of our summer season. Shows are currently running every Wednesday, Friday, and Sunday with extra shows booked throughout.

We are very happy to announce that we have been approved for funding from Veterans Affairs Canada in the amount of \$3900. This contribution will assist with the eligible costs of the Remembrance Day ceremony and reception and the musical production entitled A Night to Remember on November 11 and 12, 2010, respectively. Due to this funding being subject to the execution of a Partnership Contribution Agreement we are unable to make any announcements until papers are signed.

This funding is specifically allotted to certain areas that we must follow. I would like to suggest that the Kings Playhouse organize both events with Town Council assisting. Dear Mayor and Council:

On behalf of the Georgetown Fire Department I cordially invite you to our open house and unveiling of the restored fire siren on Saturday July 24th 2010 at the Fire Hall located on 70 Grafton Street starting at 2:00pm.



Two years ago the Fire Department decided to start restoring and erect the old fire siren that had sat idle for the past 15 plus years. I am pleased to say that after many hours of work the siren was completed the first of June with the hook up to electricity. The siren which was purchased in April 1967 served the town well until such time as technology advanced and we were able to afford pagers for each member of the department.

The siren will no longer be used for regular fire calls; however will serve the community if there is ever a major disaster or fire that we have to warn residents. Also the department has set up the siren to ring daily at 12:00 noon for 3 seconds much like they do in Charlottetown at 12:30pm. This will ensure the siren is in working order and also as a dedication to those deceased members who served the community in the Fire Department over the years.

We hope you will be able to attend and help us commemorate this part of our history!

Things in recreation have been really busy this past month. The summer camp program started up, and everything is going great so far, and we are having a lot of fun. I recently had a summer student hired to work with me for the summer, and she is helping out with the camps, and starting up new recreation programs. She will be with us for eight weeks in total. As most of you already know, Georgetown was recently named a top 20 finalist of the Kraft Celebration Tour, which was a very big thing for

this community, and we should be proud of ourselves to have made it that far.

The summer camp program started up on Monday July 5th, and currently 21 children are enrolled in it. The program goes from Monday-Thursday in the mornings, and will run for 8 weeks, ending Thursday August 26th. We do a different sport every week. My summer student Lauren MacKenzie had been helping out with this and everything has been going well, and we look forward to the rest of the summer.

I recently signed Georgetown up to get involved in the Go! PEI program, and will be up and on the go soon. This program has just been recently developed in hopes of getting all Islanders active and staying healthy. A number of different communities have signed up for this program, and looking forward to getting it started. They will be giving me a budget to work with, and I will use this money to help promote the programs and get the supplies needed to run them. The programs that I selected to sign up for are a Physical Activity 101 course. This is a 6 week course for anyone interested, and it promotes physical activity and ways it should be incorporated into our everyday lives. The second program is a walking promotion program. This program will take place once a week, where everyone who is interested can come out and establish a walking culture in the community. The third program is a healthy snack program. This is a program where during events or programs in the town, the money is used to buy some healthy snacks to provide people with and educate them of the importance of the healthy snacks. Finally the fourth program is a cycling program. This program is similar to the walking program where we form a biking club, and then plan on a relay for everyone to participate in. With this go! PEI program, I feel that it's a good way to become a more healthy and active community.

The Kraft Celebration Tour voting period came and went recently, and I must say that we should be proud of ourselves here in Georgetown. It was great to see all the community support, the dedication in everyone, and it really shows how much our residents really care about our rink. One thing that I personally learned from this, is that everyone in Georgetown sticks together, and if they really want something, they do everything in their power to achieve that feat. I was overwhelmed with the support received, and I really hope that we come out on top, because this community really does deserve it. Regardless, if we win or lose, we should be very proud of the effort put forth, and give ourselves a pat on the back for a job well done, and be honored that we are part of such a great community.
