### Town of Georgetown

RESOLUTION – Impact of Federal Job Cuts in Prince Edward Island:

**WHEREAS**, job cuts announced in the 2012 federal budget represent 4.8% of the permanent federal workforce;

WHEREAS, recent study prepared by McInnes Cooper for the Province of Prince Edward Island, the City of Charlottetown, PSAC and PIPSC estimates federal job cuts will represent approximately 10% to 12% of the current permanent federal workforce in Prince Edward Island:

**WHEREAS**, the direct and indirect impact of these cuts are expected to result in an economic loss of between \$50.46 and \$61.02 million, or about 1.01 to 1.22% of the provincial GDP.

**WHEREAS**, the proposed federal workforce reduction will disproportionately impact the economy of Prince Edward Island as compared to the balance of Canada;

WHEREAS, Prince Edward Island has historically had one of the highest rates of unemployment in the country with an economy unable to absorb further negative impacts on employment; and

**WHEREAS**, the projected negative economic impact of the Federal Budget has and will be felt province-wide, from our largest city to our smallest communities;

**THEREFORE BE IT RESOLVED** that the Town of Georgetown call on the Government of Canada to ensure that the proposed reduction in the federal workforce does not have a disproportionate negative impact on the economy of Prince Edward Island;

**BE IT FURTHER RESOLVED** that the Town of Georgetown take the necessary action to voice opposition to the Prime Minister, their Member of Parliament and their Member of the Legislative Assembly on the negative impact the Federal Budget has within their community and the Province of Prince Edward Island;

**BE IT FURTHER RESOLVED** that the Town of Georgetown seek the involvement of local community leaders to assist in delivering the message to the Federal Government.

<u>Public Works, Property/Utilities</u>: Sewer issues on Kent St. have been dealt with for now. Every year we have similar things occurring. Grease, paper and other objects are being put down the sewer lines. Video and flushing of these lines is quite expensive. Again, I ask residents to be aware of this. Next sewer utility billing I would like a notice to be sent out just to remind customers of this practice.

Received a quote to patch and overlay sections requiring repairs from Island Construction Ltd.: \$14,300 + \$715 GST = \$15,015.

<u>Community Heritage & Beautification:</u> Town is looking great! Joey, Maintenance Crew and Naomi and Gardens Crew deserve a lot of credit for this. I would like to send them an appreciation letter thanking them for their exceptional work.

Floating Fountain and pond is complete with the addition of 225m of new pathways, flower beds and trees. Looks fantastic, a definite centre point for the Town and Gardens.

A few things left to do:

Dedication plaque to Bev and Virginia Breedon. Without their donation to the A.A. Macdonald Memorial Gardens this would not have been possible.

Pave 225m of new pathways. Joey and public works crew installed this at a considerable saving to the Town.

Received a quote to pave 225m from Island Construction Ltd: \$7,000 + \$350 GST = \$7,350.

I would like to thank: Department of Environment, Energy and Forestry for their kind donation of trees to the gardens project via Greening Spaces Program.

Now that this project is near complete I commend Council for allowing me to this project. I have other things in mind for the gardens and am willing to do this. If council would like to see more for the gardens these things could be possible.

### **Town of Georgetown**

RESOLUTION – Development of a new long-term federal plan for municipal infrastructure funding:

WHEREAS, The Building Canada Plan and a number of important federal-provincial transfer agreements vital to Canada's cities and communities, will expire in March 2014;

WHEREAS, Federal investments over the last few years have helped to slow the decline of our cities and communities, and the Government of Canada has committed to develop a new long term plan for municipal infrastructure funding in consultation with municipal and provincial/territorial governments;

**WHEREAS**, a seamless transition from the Building Canada Plan to a new long term plan is necessary to ensure that municipalities can continue planning their capital spending effectively;

WHEREAS, The Federation of Canadian Municipalities (FCM) has launched a campaign to ensure the new plan reflects municipal priorities across the country and asks its member municipalities to pass a Council resolution supporting the campaign;

AND WHEREAS, our community has continuing infrastructure needs, such as Storm Water Upgrades, Georgetown Sewer Lagoon Phase III Upgrades, Civic Center (including Fire Dept., Library and Town Hall) expansion, renovations and additions to building and parking lot, Sewer mains replaced on Kent Street, and our Main Street, AA Macdonald Gardens Improvements and Three Rivers Sportsplex that can only be met with through the kind of long-term planning and investment made possible by a national plan;

THEREFORE BE IT RESOLVED that Council endorses the FCM campaign and urges the Minister of Transport, Infrastructure and Communities to work with FCM to ensure the new long-term infrastructure plan meets the core infrastructure needs of cities and communities;

**BE IT FURTHER RESOLVED** that Council urges the Minister of Transport, Infrastructure and Communities to ensure that the new long-term plan is fully in place when existing programs expire in 2014: and

**BE IT FURTHER RESOLVED** that a copy of this resolution shall be sent to the Minister of Transport, Infrastructure and Communities, to the Provincial Minister of Municipal Affairs, to the local MPs, to the Federation of Canadian Municipalities and to the Federation of Prince Edward Island Municipalities.

- 3. That Lewis Lavandier, Wade Williams, Allan Gallant, Tonya Cameron (any two of the four) acting on behalf of the Town of Georgetown are hereby authorized to sign on behalf of the Corporation and to furnish to the Bank an Agreement or Agreements under the seal of the Corporation providing for payment to the Bank of all amounts required to be paid by the Bank pursuant to each promissory note of the Corporation guaranteed by the Bank with interest at such rate as the Bank may from time to time determine and of a guarantee fee in respect of each such promissory note at such rate as the Bank may from time to time determine.
- 4. That <u>Town of Georgetown Town Council</u> are hereby authorized and directed to furnish to the Bank at the time of each borrowing and at such other times as the Bank may from time to time request, a statement showing the nature and amount of the estimated revenues of the current year not yet collected or where the estimates for the year have not been adopted, a statement showing the nature and amount of the estimated revenues of the Corporation as set forth in the estimates adopted for the next

preceding year and also showing the total of any amounts borrowed in the current year and in any preceding year that have not been repaid.

5. That Lewis Lavandier, Wade Williams, Allan Gallant, Tonya Cameron (any two of the four) acting on behalf of the Town of Georgetown are hereby authorized and directed to apply in payment of all sums borrowed from the Bank, with interest thereon, all of the moneys hereafter collected or received on account or realized in respect of the taxes levied for the current year and for any preceding years and all of the moneys collected or received from any other source.
